Motion Molacek, second Annette to approve August Minutes, August Emergency Minutes, Bills and Committed Monies as presented. Motion carried. (5-0)

# Liquor:

- New POS system is in operation and going well.
- New security camera has been installed.
- MN Dept of Health did an inspection of the liquor store and event center. Passed with no issues.
- The theft of petty cash at the liquor store has been turned into insurance. There is a \$250 deductible.
